TECHNICAL SUMMARY:

Application and scope:

ASSE 1084 is for water heaters have a cold water inlet connection, a means of heating the water, a means of controlling the water temperature, a means of limiting the temperature to a maximum of 120 °F (48.9 °C), and have an outlet connection to connect to downstream fixture fittings.

ASSE 1085 is for water heaters supplying tepid water to emergency equipment, including eyewash, eye/face wash, emergency showers, and combination units. These water heaters heat the cold water supply to an acceptable tepid temperature within the intended range listed in ISEA Z358.1.

Effect on Approvals:

Any new submission for CSA certification will be according to ASSE 1084-2018e1(R2023) and ASSE 1085-2018(R2023) as of the issue date of this document.
